1946	OSCAR E. CHYTRAUS (OEC) SIGNS A DEALERSHIP AGREEMENT WITH CRAWFORD DOOR MANUFACTURING TO SELL, SERVICE AND INSTALL THE CRAWFORD "MARVEL-LIFT" DOOR.
JUNE 1, 1953	RONALD E. CHYTRAUS STARTS FULLTIME EMPLOYMENT WORKING WITH HIS FATHER OSCAR E. CHYTRAUS; HIS THREE YOUNGER BROTHERS, HOWARD, RICH AND GARY SOON JOIN THE FAMILY OWNED BUSINESS.
MAY 16, 1988	CDC, INC. DBA CRAWFORD DOOR SALES OPENS FOR BUSINESS AS AN EMPLOYEE-OWNED COMPANY. FINANCIALLY BACKED BY 11 ORIGINAL EMPLOYEE INVESTORS AND 3 OUTSIDE INVESTORS. AFTER FORTY-TWO YEARS, EIGHTEEN CDC, INC. EMPLOYEES CARRY ON THE TRADITION AND COMPANY REPUTATION STARTED BY OUR FOUNDER, OSCAR E. CHYTRAUS.
SEPTEMBER 23, 1992	UTAH DOOR SYSTEMS, INC. (A SEPARATE CORPORATION) BEGINS BUSINESS OPERATIONS BACKED BY THE SHAREHOLDERS OF CRAWFORD DOOR SALES AND MANAGED BY R.W. "DICK" HOELLE
DECEMBER, 6, 1993	CRAWFORD DOOR SALES MOVES FROM ITS LEASED WAREHOUSE TO OUR CURRENT 21,000 SF FACILITY LOCATED AT 155 WEST 2700 SOUTH, SOUTH SALT LAKE, UTAH.
OCTOBER 1996	GREGORY D. SCHULTS IS ELECTED PRESIDENT AND CEO, RICHARD A. HURTY AS V.P. AND RONALD E. CHYTRAUS REMAINS AS CHAIRMAN OF THE BOARD
MARCH 1, 1998	CRAWFORD DOOR SALES BECAME UTAH'S 1ST IDEA ACCREDITED DOOR DEALER
OCTOBER 2000	CRAWFORD DOOR SALES RECEIVES THE COVETED DOROTHY M. COOKSON AWARD PRESENTED TO THE EMPLOYEES OF THE COMPANY BY ROBERT COOKSON
2000	CRAWFORD DOOR SALES IS RECOGNIZED BY THE INTERNATIONAL DOOR ASSOCIATION AS THE NUMBER 17TH TOP DOOR DEALER IN THE GARAGE DOOR INDUSTRY IN THE U.S.
JANUARY 16, 2001	CRAWFORD DOOR SALES OF IDAHO, INC. (CDSI) BEGINS BUSINESS OPERATIONS, MANAGED BY MICHAEL J. BELTRAMI. CDSI WAS FINANCED BY THE INVESTORS OF CDC, INC. AND THE ORIGINAL IDAHO EMPLOYEES.
FEBRUARY 9, 2006	CRAWFORD DOOR SALES OF NEVADA, LIMITED (CDSN) BEGINS BUSINESS OPERATIONS, MANAGED BY INDUSTRY VETERAN JACK C. GOSS. CDSN HAS COMMON SHAREHOLDERS WITH CRAWFORD DOOR SALES OF SALT LAKE AND UTAH DOOR SYSTEMS, INC.
2006	CRAWFORD DOOR SALES WAS RECOGNIZED BY ALBANY DOOR SYSTEMS AS THEIR TOP DISTRIBUTOR IN THE UNITED STATES
MAY 16, 2008	CRAWFORD DOOR SALES PROUDLY CELEBRATES TWENTY (20) YEARS OF SUCCESSFUL BUSINESS OPERATIONS AS AN EMPLOYEE OWNED COMPANY.
